A BRIEF REPORT

LACK OF FINANCE SHOULD NOT BE A REASON FOR DEPRIVATION OF EDUCATION

Kanara Welfare Trust, pioneer Institution of Uttar Kannada District has been working for the cause of education and social upliftment for the last six decades. Its main concern has been the emancipation of the poor and downtrodden people of the district.

The Trust has once again come forward with a new project which envisages financial assistance to those who, due to lack of financial resources, are deprived of pursuing higher education.

Kruger Foundation for Child Aid, Karwar, in collaboration with Shri Devadatt Kamat, Advocate Supreme Court of India, and a man of vision, have been sponsoring this novel project, "Financial Assistance for Education", which is being executed by Kanara Welfare Trust to help the poor and deserving students of Uttar Kannada. The Trust and the sponsors of this project believe that no student should be deprived of higher education due to lack of financial resources.

The project commenced from the year 2012-2013. Since then, every year, fresh batches of meritorious and deserving students of U.K. District are selected and awarded scholarships of Rs.3000 each. However, from 2019-2020 onwards, the scholarship amount has been raised to Rs.5000 each. The details of scholarships disbursed under this scheme till date is as below.

Till date, 3075 scholarships have been disbursed. Nearly One Crore Rupees has been distributed as financial assistance to the deserving students. The continuation of this scholarship was assured to them provided they maintain their percentage level.

This year, a total of 214 students are listed for aid under this scheme. These students come from PU & Degree levels of education. The Trust received more than 600 applications from across Uttar Kannada District. The applicants are mainly from low income groups but diverse communities such as farmers, labourers, fishermen, etc.

The scrutiny committee perused the applications received and shortlisted 350 potential beneficiaries. Teachers and volunteers from various Trust Institutions physically visited the houses of the students and observed their economic and social conditions firsthand. After due verification, they recommended these deserving students based on merit and financial position of the family. The list of recommended candidates submitted by the committee was duly approved by the Chairman.


This year, among the beneficiaries, the highest percentage scored at the SSLC level is 95.84% and at the Pre-University level it is 96.33%. Generally, students scoring more than 80% marks are eligible for the scholarships. However, the cut-off marks have been relaxed in some genuinely deserving cases.

This year, out of the total 215 selected applicants, <u>165</u> are girls & <u>50</u> are boys. The trend of meritorious girls outnumbering the boys continues. Science & Commerce are popular streams of study at the PU level and B.Com. at the Degree level as is evident from the table below.
