A REPORT



Kanara Welfare Trust, pioneer Institution of Uttar Kannada District has been working for the cause of education and social upliftment for the last six decades. Its main concern has been the emancipation of the poor and downtrodden people of the district.

As a part of the campaign for alerting the youths to the social, economic and political problems of our country and for developing leadership quality among them, Inter-Collegiate Debate Competitions and Lecture Series are being organized on an annual basis.

Shri Devadatt Kamat, Advocate, Supreme Court, and son of **Shri S.P.Kamat**, the present Chairman of Kanara Welfare Trust, is sponsoring this District Level Inter-Collegiate Debate Competition in memory of his grandfather, Late P.S.Kamat.

Late P.S.Kamat shared the vision of KWT's founder, Dr. Dinkar Desai and was associated with Divekar College of Commerce and the Trust. He was a Gandhian and actively participated in the freedom struggle losing his Law Sanad which was restored later under Gandhi-Irwin Pact. He was an eminent Sanskrit scholar, freedom fighter, a legal luminary and an inspiring orator. He was an educationist



who headed the Academy of General Education which established the first full-fledged College in Karwar which is presently known as Govt. Arts & Science College. He worked for the unification of the then Mysore State, subsequently named Karnataka State. He headed the District Congress Committee and was responsible for getting all the Congress candidates elected in Uttar Kannada District in the first general elections. He was Member of Legislative Council in Bombay Province between 1951 and 1957.

An attempt is made to realize his dreams of making the youth better leaders and creative personalities by organizing a District Level Inter-Collegiate Debate Competition open to students of all Pre-University and Degree Colleges, Technical Institutions and Engineering Colleges of Uttar Kannada.

Devadatt Kamat hails from Karwar in Uttar Kannada District, Karnataka, and is a fourth generation lawyer, practicing in the Supreme Court of India. His father, S.P.Kamat is a senior advocate practicing at Karwar & actively involved in running more than 50 educational & social Institutions in Uttar Kannada District. Devadatt Kamat has inherited the legacy of his grandfather and father and is actively involved in creating a new social awareness in the Uttar



Kannada District through several social projects benefitting the people of Uttar Kannada – mainly those who are backward - economically and socially. In his legal career, he was involved in defending the Govt. reservation policy before the Supreme Court. He also actively worked and participated in defending the Govt. initiative in introducing the Right to Education Act, in the Supreme Court. His interest in the development of Uttar Kannada District so also the interest in upholding the rights of the lesser privileged people is abiding and deeply rooted. His deeper interest in philanthropic initiatives have prompted him to participate in various programmes aimed at poverty alleviation, rural health, youth empowerment, education for the children from backward classes & areas and the like.

Devadatt Kamat is sponsoring this District Level Inter-Collegiate Debate Competition in memory of his grandfather, Late P.S.Kamat.

The event was organized jointly by Kanara Welfare Trust and Divekar College of Commerce, Karwar. Around 162 colleges [50 Degree Colleges, 87 PU Colleges and 25 other Colleges] across the district were invited to participate in the competition. The competition was conducted at 3 stages – College Level, Taluka Level & District Level. More than 600 students from around 85 colleges participated in the first round.







The inauguration ceremony commenced with the invocation by **Miss Namrata Gaonkar**, *student of Gokhale Centenary College*. Both points of view are extremely strong, extremely sensitive. But time has come; and there are whispers from every corridor of the political parties that we need to take this to a different level. After sixty years of independence we need to give a fresh thought to this issue of reservation."



H.E. Mr. Idriss Raoua OUEDRAOGO, *Ambassador Extraordinary and Plenipotentiary of Burkina Faso,* delivered the inaugural address.

"First of all, I would like to pay my homage to my Masters, our teachers and their families who are working day and night to feed us with knowledge and wisdom. My benevolent homage goes to Dr. Dinkar Desai who originally brought this vibrant environment by converting his thoughts into action and my friends here who took up his ideals to make the Trust what it is today.

I was very impressed by seeing how the youth of this part of Incredible India have been taking up the issues in the competition. I was not able to understand the language but their body language was very lively and self-explanatory. I must congratulate all of you for your achievement.

My friends, I come from a country called Burkina Faso, which means 'land of honest people'. In my present position, I have got an opportunity to learn lots and lots from India. I always say, "Burkina is my Fatherland, India is my Motherland". We are here in India to learn from you. We congratulate the achievements made by the people of India. We call the people of India our eldest brother. We need to join our hands together to move forward to form what we call an egalitarian society. The vision laid by your Trust is the appropriate way — which is education. We must move ahead through education to help all people without any discrimination. Before going to school, we should have the privilege of having access to schools. This is the major initiative taken by the Kanara Welfare Trust, which by way of opening schools has provided quality education to all without discrimination. To support and educate the underprivileged by giving them access to knowledge is the best help. I am impressed by Mr. Kamat and his family spreading this love of knowledge in different circles of the community. I must say that they are the real builders of the society. I will recall the words of Martin Luther King who said that, 'we have to live together as brothers or perish together as fools'.

A great Himalayan saint, Swami Rama has said, "A human being is a citizen of two worlds, and he or she has to develop the ability to have access to both without any confusion. Clarity of mind comes if you have learned to direct your mind according to your desire and goal." Today, youth need to be balanced citizens of these two worlds - that is to look inside, have the knowledge and potential to discover your true self and your goal of life, to gain the opportunity to express yourself in the service of humanity. Here I can say without any doubts that Dr. Dinkar Desai and all those who are promulgating this initiative today are the brilliant examples of 'the citizens of these two worlds'.
